#### Objective

Students are also required to play pawn auction simulation in class with the whole participants in the class.

The principle of sharia is the principle that is a reference in Islamic economic principles and the uniqueness and differences existing in conventional economic norms. Financial institutions of Islamic finance *non*-bank includes insurance (*takaful*), mortgages (*Rahn*), Islamic mutual funds, *Ijara* (leasing), financial institution pension funds (Pension Fund) sharia, and *Baitul Maal wa tamwil* (BMT).

The practice of sharia pawnshops (*rahn*) is one of shariah financial activity which can be socialized to whole the world, which is considered valuable or has economic value by Islamic terms
