





FEB AT A GLANCE

The forerunner to the Faculty of Economics, Ahmad Dahlan University, was initiated in 1956 when this university was still in the form of FKIP Muhammadiyah in Jakarta in the form of a B1 course in the Department of Economics. In its development, on December 19, 1994 the Yogyakarta Muhammadiyah Teachers' Training College (IKIP) changed its function to become Ahmad Dahlan University (UAD), since then the Faculty of Economics (FE) was also born. Initially, FE UAD opened the Development Economics Study Program, then in 1996 the Management Study Program was opened and in 1999 the Accounting Study Program was opened. In 2016, FEB UAD reopened the Masters in Management study program and in 2017 again opened the Applied Undergraduate study program Diploma 4 (D4) Food Service Business (BISMA) FEB UAD has collaborated with various universities both at home and abroad such as Mlaysia, Thailand, China, Korea and others. This collaboration provides opportunities for students to conduct student exchange.
